

Provisions and conditions OBJECT Rotterdam 2012

1. Organisation

The OBJECT Rotterdam design fair is the property of and will be organised by OBJECT Rotterdam BV.

2. Location and opening hours

OBJECT Rotterdam will take place in LPII in Las Palmas on the Wilhelminakade 330-334, Kop van Zuid, in Rotterdam from Wednesday February 8 up to and including Sunday February 12, 2012.

3. Assembly and disassembly

Assembly is only possible on Tuesday February 7 between 08.00 and 24.00 and on Wednesday February 8 between 08.00 and 12.00. On Wednesday February 8 the stands should be equipped and cleared up by 12.00 at the latest. Stands must be manned during all opening times including during the private opening times. Stands should be cleared on Sunday evening February 12 by 00.00 at the latest. Disassembly takes place on Sunday February 12 from 19.00 to 00.00.

4. Registration

Registration is only possible by way of the enclosed registration form. This form does not guarantee participation. All applications for participation will be presented for assessment. The registration form should be in the possession of the organisation by September 20, 2011 at the latest.

5. Acceptance, admission and payment

Acceptance of registration will take place following approval by the organisation. Upon acceptance (half October) an advance payment of € 1.500,- must be made before the 1st of November 2011. The remaining payment of the stand rental and the fixed charges plus the statutory V.A.T. are to be paid before the 1st of December 2011. As long as the payment requirements have not been met, the participant has no entitlement in any form. All (payment collection) costs arising from not paying invoices on time will be charged entirely to the participant. In the event of one or more accounts not being paid on time the organisation is entitled to provide the place allocated to another party without further intervention.

6. Cancellation of registration / breach of contract

In the event of cancellation of the registration or breach of contract then, up until 3 months before the artfair, 50% of the total costs of participation must be paid by the exhibitor to the organisation. After this 100% of the total costs of participation must be paid by the exhibitor to OBJECT Rotterdam.

7. Stand, lighting and catalogue

Each stand will be provided with one wall, a frieze and a name plate. The price for renting a stand is € 175,- (excluding VAT) per square meter and a fixed amount of € 750,-. Without the express permission of the organisation the participant is not entitled to place anything whatsoever outside the red lines of the surface area rented by him. The costs of the wall include standard lighting.

8. Admission tickets for contacts and participants

Each participant will receive from the organizers 5 vip tickets. These tickets provide an entitlement to free admission during the preview, opening or on other exhibition days. In addition there will be 75 tickets for 1 person for the official opening and 25 tickets for 1 person for the official opening or free admission to the other exhibition days. Participants are obliged to wear the fully completed 'participants badges' in a clearly visible manner. Each stand holder is entitled to a maximum of 4 badges. These are strictly personal and may only be used by the participants themselves. In the event of misuse these badges may be immediately withdrawn by the organizers.

9. Security

The organizers will provide security outside of assembly, opening and disassembly times from Tuesday February 7 at 08.00 to Sunday February 12 at 00.00. In order to prevent theft during the art fair all purchases leaving the art fair should be provided with a fully-completed and signed 'exit slip' which will be issued to you by the organizers. During setting up, opening and disassembly times the care of goods is expressly at the expense and risk of the participant.

10. Qualification

The organisation is not liable for loss, theft or damage to persons or goods in whatever form. The participant is obliged to take out proper insurance for this. The organizers are entitled to ask for proof of insurance if they consider it necessary.

11. Force majeure

If the design fair is cancelled, delayed or shortened through unforeseen circumstances or circumstances beyond its control then the organisation may not be held liable in any event. Participants may in that case not make any claim for damages or repayment by the organisation.

12. General

The organisation will decide in all cases which are not foreseen by these provisions and conditions. The instructions of the OBJECT Rotterdam organisation or an executive organizer appointed by the organisation must be complied with at all times. In the event of a dispute the Court of Rotterdam is solely competent. All information has been put together with care but the OBJECT Rotterdam organisation may not be held liable for its accuracy and no rights may be derived from the details provided. This information is expressly not to be considered as an offer or tender.
